Single Gift: A one-time gift of cash, cheque or online at cclegacy.ca.nmsrv.com

Gift of Securities: Donations of publicly traded securities such as shares, bonds and mutual funds provide you a greater tax benefit as you are exempt from paying capital gains tax on the donated security. PLANNED GIFTS

Gift in your Will: Arranged today, a bequest gift is left in your will. You can give a specific sum, property, or a percentage of your estate. So that there is no confusion about your intentions, it is important that the full name of the parish and charitable number be included in your will: Corpus Christi Parish, Vancouver # 11884 9470 RR0028.

Life Insurance: A gift of life insurance provides tax benefits to you and your estate and can be given now or later. Insurance allows you to make a modest investment now for a significant gift in the future.

RRSP and RRIF Funds: Can be gifted in whole or in part by naming Corpus Christi as the beneficiary.

Charitable Gift Annuities: With a charitable gift annuity, a portion of your contribution is used to purchase an annuity for you while the remainder goes directly to Corpus Christi as a gift. Charitable Gift Annuities also provide significant tax benefits.

Real Estate and Gifts-in-Kind: It is possible to donate real estate (e.g. your house or cottage) or other property (e.g. a favorite painting) to Corpus Christi and receive a tax-receipt. Please call the parish office for more information.
